6月1日,2023年长三角外资协会联盟暨中国外商投资企业协会高质量发展分会会议在 浙江省台州市天台召开,中国外商投资企业协会、长三角外资协会联盟成员12家成员单 位负责人近30人出席会议。会议由浙江省外商投资企业协会轮值会长张晶主持。中国外 商投资企业协会常务副会长曹宏瑛讲话,上海市外商投资协会会长黄峰、安徽省外商投资 企业协会会长张箭以及上海市浦东新区、静安区、奉贤区、浙江省杭州市、宁波市、江苏 省苏州市吴江区、厦门市、威海市外资企业协会的负责人分别作了交流发言。黄峰会长介 绍了中国外资协会高质量发展分会的工作情况,分会办公室已落户虹桥国际中央商务区, 分会定期举办虹桥外企联谊会活动、并计划举办外商投资企业绿色低碳发展研讨会。(图2)

### 市政府发展研究中心到协会开展在沪外资企业发展情况座谈会

6月13日,上海市人民政府发展研究中心副主任严军一行来上海市外商投资协会调研外 资企业工作,并召开在沪外资企业发展情况座谈会,面对面听取外资企业对优化上海营商 环境的建议。市政府发展研究中心开放处处长陆丽萍、副处长钱洁及开放处其他相关负责 人参与调研。上海市外商投资协会相关负责人及雅培、索尔维、博世、安进、上好佳、埃 森哲6家会员企业代表参加座谈会。

座谈会上,企业代表踊跃发言,围绕企业在沪发展的总体情况、目前面临的主要问题、制 度障碍等内容与调研组展开交流,并为优化上海营商环境建言献策。调研组充分听取企业 诉求,就企业关心的重点问题、目前遇到的难点问题,与企业进行深入沟通和探讨。严军 副主任表示将在调研会上讲到的问题进行整理并和相关政府部门沟通,推动解决企业经营 过程中遇到的相关问题。

### 黄峰会长和 11 家会员企业参加上海知识产权工作情况通报会

6月15日,2023年上海知识产权工作情况通报会召开。市知识产权联席会议召集人、市 知识产权局局长芮文彪专题通报了上海知识产权工作最新发展状况,市高级人民法院副院 长黄祥青通报了上海法院知识产权司法保护情况。上海市外商投资协会组织武田、3M、 巴斯夫、恒天然、花王、开云、联合利华、耐克、三联书店、庄臣、特斯拉11家会员企 业现场参会。协会会长黄峰及协会相关负责人出席会议。

在交流发言环节,部分领馆、商会、企业代表分别围绕知识产权执法领域工作重点、商业 秘密保护、基层法院知识产权案件管辖、专利等知识产权审批周期、打击商标恶意抢注、 上海市重点商标保护名录申请等问题进行提问,上海市知识产权联席会议各成员单位现场 回应解答。

On June 13, Yan Jun, Deputy Director of the Development Research Center of the Shanghai Municipal People's Government led a delegation to visit SHFIA, where they investigated work related to foreign enterprises, and held a symposium on the development of foreign enterprises in Shanghai to listen to opinions from foreign enterprises on optimizing Shanghai's business environment. Director Lu Liping, Deputy Director Qianjin and officials from the center's Business Openness Office also participated in the symposium, which was attended by representatives from SHFIA and six member enterprises, Abbott, Solvay, Bosch, Amgen, Oishi, and Accenture.

At the symposium, enterprise representatives exchanged ideas with the investigation team on the overall situation of their business development in Shanghai as well as the main challenges and institutional obstacles they are currently facing, and offered suggestions for optimizing Shanghai's business environment. The investigation team fully listened to the needs of the enterprises,

and conducted in-depth communication and discussions on the key issues that the enterprises are concerned about and the difficulties they are currently facing. Yan Jun said that the investigation team would summarize the issues noted at the symposium and communicate with relevant government departments to drive the resolution of related challenges that foreign enterprises face.

# Chairman Huang Feng and 11 member enterprises attended Shanghai's IPR work briefing

On June 15, the 2023 Shanghai Intellectual Property Rights Work Briefing was held. Rui Wenbiao, Convener of the Shanghai Municipal IPR Joint Conference and Director of the Shanghai Municipal Intellectual Property Administration, delivered a special report on the latest developments of Shanghai's IPR work. Huang Xiangqing, Vice President of the Shanghai Municipal Higher People's Court, reported the judicial protection of intellectual property rights by Shanghai courts. SHFIA organized 11 member enterprises including Takeda, 3M, BASF, Fonterra, Kao, Kering, Unilever, Nike, Joint Publishing, SC Johnson, and Tesla to attend the briefing, where Chairman Huang Feng and key association officials were also present.

During the Q&A session, representatives from foreign consulates, chambers of commerce, and foreign enterprises raise questions about the priorities in the field of IPR law enforcement, protection of trade secrets, jurisdiction of IPR cases by grass-root courts, IPR approval cycle, crackdown on malicious trademark squatting, and application for inclusion in Shanghai's list of protected trademarks, which were answered by members of the Shanghai Municipal IPR Joint Conference on the spot.

Also at the seminar, Zhu Weixian, Shanghai Office Partner of Beijing Tianchi Law Firm, gave a vivid explanation of the elements and practices of trade secret protection, while Shen Xiaodong, Deputy Patent Director of AntChain, introduced the company's public–service platform for trade secret protection, confirmation and certificate deposit under the background of blockchain technology.
