7 SHFIA member enterprises attended 9th SCC roundtable meeting on protection of consumer rights and interests On October 27, the Shanghai Consumer Council (SCC) and SHFIA coorganized the 9th roundtable meeting on the protection of consumer rights and interests for foreign enterprises. Tao Ailian, Secretary-General of SCC and Second-Grade Counselor of the Shanghai Municipal Administration for Market Regulation (SMAMR), delivered a keynote speech at the meeting, which was also attended by officials from SMAMR 's consumer rights protection division, online supervision division and food business operation division, the Shanghai Municipal Administration of Ecology and Environment (SMAEE), the Shanghai Intellectual Property Administration (SIPA), the SCC Secretariat, and SHFIA. Representatives from 7 SHFIA member enterprises including Starbucks, Lululemon, Mondel ē z, Meiji, Nori, EFO, and Henkel attended the roundtable meeting, who raised questions and offered suggestions on topics such as new consumption model and new challenges in rights protection. And their questions were answered by corresponding officials from SCC, SMAEE, SMAMR, and SIPA. (Photo 2)

SHFIA led more than 100 enterprises to participate in 134th Canton Fair

On October 15, the 134th China Import and Export Fair ("Canton Fair") opened in a physical form, with the exhibition scale reaching a new high. As the organizer of the Shanghai Trade Mission's Foreign Investment Sub-Mission, SHFIA organized 105 enterprises to participate in this year's Canton Fair. These enterprises set up a total of 419 offline booths, including 84 brand booths as well as 335 exhibition booths with special green set-up or unified layout. The exhibits of participating enterprises covered 35 exhibition categories, including tools, motorcycles, automotive parts, construction and decorative materials, kitchen utensils, household products, luggage, etc. On the fair's opening day, Fan Hong, Secretary-General of SHFIA, visited some of the sub-mission's participating enterprises to learn about their participation.

Seminar on Shanghai's Talent Settlement Policy

On October 18, SHFIA held a seminar on Shanghai's talent settlement policy at the association's grand conference hall. The seminar invited He Jiayin from the city's talent service center to present and interpret relevant policies for more than 80 HR professionals from foreign enterprises. The seminar was the first event of the Shanghai Municipal Commerce Commission 's foreign investment policy seminar series.
