

11月2日,上海市外商投资协会邀请普华永道中国研发优惠服务合伙人郭欢洁女士,举办了《研发费用加计扣除政策执行指引2.0》介绍及案例分享讲座,为参会企业介绍有关研发费用加计扣除政策方面的相关信息。近40名企业代表线下参加本次活动。讲座专注

于国家税务总局所得税司和科技部政策法规与创新体系建设司于2023年7月联合发布的《研发费用加计扣除政策执行指引(2.0版)》,围绕研发活动界定、研发项目管理、实务案例、高新技术企业特性问题几个话题板块,向参会企业代表进行了分享,并在问答环节与听众进行互动。

协会举办《市场监督管理投诉信息公示暂行规则》政策解读讲座

11月14日,上海市外商投资协会举办《公示规则》政策解读讲座,邀请上海市市场监督管理局消费者权益保护处处长谢正豪从行政监管的角度为参会企业进行讲解。35位企业代表线下参加此次活动。讲座上,谢处长介绍了全国12315消费投诉信息公示平台功能,对《公示规则》中公示内容、方式、审核以及不予公示的情形等内容进行了解读,就企业消费者投诉处理工作提出了建议。在问答环节,谢处长回应了企业关于消费争议解决机制(ODR)先行和解、投诉处理及公示流程等问题。

协会举办人社执法监察工作讲座

11月16日,协会举办人社执法监察工作讲座,邀请市人社局执法总队第二支队徐臻副队长作宣讲,来自本市外资企业的60余名人力资源管理相关人员参会。徐队长从执法案例来源、执法依据及程序、执法案例分享、案例拓展等四个方面完整地介绍了本市人力资源与社会保障执法监察工作,重点分享了加班工资计算和年休假计算的有关案例,在答疑环节回应了来自参会企业关于人社执法的相关问题。



In November, SHFIA held 15 events. Throughout 2023, SHFIA has held a total of 127 events.

Seminar on "Implementation Guidelines 2.0 for the Super Deduction Policy of R&D Expenses"

On November 2, SHFIA invited Guo Huanjie, PwC China's R&D preferential services partner, to hold an introductory and case-sharing seminar on the "Imple mentation Guidelines 2.0 for the Super Deduction Policy of R&D Expenses" to introduce R&D-related super deduction policy to participating enterprises. Nearly 40 representatives from SHFIA's member enterprises participated in the offline event. Centering on the policy document jointly issued by the Income Tax Department of the State Taxation Administration and the Policy, Regulations and Innovative System Construction Department of the Ministry of Science and Technology in July 2023, the seminar focused on topics including definition of R&D activities, R&D project management, real-world cases, and features of high-tech enterprises. It also had a Q&A session with the participating representatives.

Seminar on "Interim Rules for Disclosure of Complaint Information on Market Supervision and Administration"

On November 14, SHFIA held a seminar on the "Interim Rules for Disclosure of Complaint Information on Market Supervision and Administration", inviting Xie Zhenghao, Director of the Consumer Rights Protection Division of the Shanghai Municipal Administration for Market Regulation, to explain to participating enterprises from the perspective of administrative supervision. 35 business representatives participated in the offline event. At the seminar, Xie introduced the functions of the national 12315 consumer complaint information disclosure platform, explained the disclosure content, methods, review and non-disclosure situations in the "Interim Rules", and put forward suggestions on how to handle corporate consumer complaints. During the Q&A session, he responded to participating enterprises 'questions about advance settlement, complaint handling and publicity procedures of the consumer dispute resolution mechanism (ODR).

Seminar on Human Resources and Social Security Law Enforcement and Supervision

On November 16, SHFIA held a seminar on human resources and social security law enforcement and supervision, inviting deputy captain Xu Zhen from the second detachment of the Shanghai Municipal Administration of Human Resources and Social Security's law enforcement brigade as the guest speaker. More than 60 human resources managers from foreign enterprises in the city attended the seminar. Xu gave a comprehensive introduction to the city's human resources and social security law enforcement and supervision work from four aspects: sources of law enforcement cases, law enforcement basis and procedures, law enforcement case studies, and additional information. He focused on sharing relevant cases on overtime wage calculation and annual leave calculation, and responded to relevant questions about human resources and social security law enforcement from participating enterprises during the Q&A session.

Foreign Enterprise Volunteer Service Committee: Yunnan Trip to Support Rural Education

From November 21 to 24, SHFIA' s Foreign Enterprise Volunteer Service Committee carried out its third public-service trip to support rural education in Nujiang Lisu Autonomous Prefecture, Yunnan Province. Fan Hong, Secretary-General of SFHIA, joined 9 volunteers from 4 member enterprises, including Ford, Granges, Dyson and Tokio Marine & Nichido Insurance, in the trip.
