## 本月聚焦 / Highlights

### 上海贸促国际商事调解中心成立

2024 年 5 月 20 日，上海贸促国际商事调解中心（Shanghai International Commercial Mediation Center, SHICMC）成立，上海市国际贸易促进委员会会长周敏浩，上海市司法局党委委员、二级巡视员张祎，上海市高级人民法院党组成员、副院长林晓镔出席揭牌仪式并致辞。协会黄峰会长出席仪式，并与上海市国际贸易促进委员会周敏浩会长、马屹副会长，上海市企业联合会副会长兼秘书长蒋苏平，上海市金融业联合会秘书长屠友富共同为上海贸促国际商事调解中心揭牌。

上海贸促国际商事调解中心由上海国际商会、上海世界贸易中心协会、上海国际经济贸易仲裁委员会（上海国际仲裁中心）、上海市企业联合会、上海金融业联合会、上海市外商投资协会共同发起，是上海市第一家由市司法局、市民政局联合审批的调解组织。

### Shanghai International Commercial Mediation Center was launched

On May 20, the Shanghai International Commercial Mediation Center (SHICMC) was officially launched at a ceremony, where Zhou Minhao, Chairman of the Shanghai Council for the Promotion of International Trade (CCPIT Shanghai), Zhang Yi, Party Committee Member and Second-Grade Counselor of the Shanghai Municipal Justice Bureau (SMJB), and Lin Xiaoni, Party Leading Group Member and Vice President of the Shanghai High People's Court, delivered speeches. Huang Feng, Chairman of SHFIA, was also present at the ceremony to unveil SHICMC together with Chairman Zhu Minhao and Vice Chairman Ma Yi of CCPIT Shanghai, Jiang Suping, Vice Chairman and Secretary-General of the Shanghai Enterprise Confederation, and Tu Youfu, Secretary-General of the Shanghai Financial Association.

SHICMC was co-initiated by the Shanghai International Chamber of Commerce, the Shanghai World Trade Centers Association, the Shanghai International Economic and Trade Arbitration Commission (Shanghai International Arbitration Center), the Shanghai Enterprise Confederation, the Shanghai Financial Association, and SHFIA. It is the first mediation organization in Shanghai jointly approved by SMJB and the Shanghai Municipal Civil Affairs Bureau.

In May, SHFIA welcomed 5 new members. And throughout 2024, 23 new enterprises have joined the association.

Comprising molding compounds labs, methacrylate monomer labs, methacrylate resins labs, Asia Technology Center is committed to providing enhanced technical support and developing innovative applications in close cooperation with local customers.
