上海市外商投资企业标准化协作平台成立

为了保障外资企业依法平等享受标准化相关政策,4月11日,上海市外商投资企业标 准化协作平台正式成立。协作平台由市市场监管局、市发展改革委、市商务委共同建 立,秘书处设在市外商投资协会,成员由外商投资企业、在沪全国标委会、上海市地 方标委会、外国商会驻沪机构、各区外商投资(企业)协会等构成,将充分发挥技术 优势、人才优势、资源优势,提供标准化服务、加强标准化协作、展示标准化成果, 为外商投资企业参与标准化工作提供有力的支撑和保障。

平台聚焦企业的标准化需求,着力打造一站式服务。一是提供标准信息查询服务;二 是开展政策宣贯和解读;三是建立常态化沟通机制。

Standardization collaboration platform for foreign enterprises launched in Shanghai

To ensure foreign enterprises can equally enjoy policies related to standardization, the Shanghai Standardization Platform for Foreign Enterprises was officially launched on April 11. The collaboration platform is co-established by the Shanghai Municipal Administration for Market Regulation, the Shanghai Municipal Development and Reform Commission, and the Shanghai Municipal Commerce Commission, with its secretariat located in SHFIA and members including the city's foreign enterprises, national/local standard committees, offices of foreign chambers of commerce, and district-level foreign investment associations. The platform will fully leverage advantages in technology, talent and resource to provide standardization services, strengthen standardization collaboration, display standardization achievements, and enable strong support and guarantee for foreign enterprises to participate in standardization-related work.

The platform will focus on the standardization needs of enterprises and strives to create onestop services including:

- 1. provide inquiry services for information on standards;
- 2. carry out policy promotion and interpretation; and
- 3. establish a normalized communication mechanism.



上海市外商投资企业劳动争议调解中心成立

在市商务委和市人社局的支持下,上海市劳动人事争议仲裁院与上海市外商投资协会 一起探索构建外企劳动争议调解工作机制,在协会成立上海市外商投资企业劳动争议 调解中心。4月11日下午,上海市外商投资企业劳动争议调解中心揭牌仪式在静安洲 际酒店举行。上海市人力资源和社会保障局二级巡视员张骁和上海市商务委员会二级 巡视员刘太秋共同为调解中心揭牌,并为调解中心首批兼职调解员颁发聘书。市人社 局二级巡视员张骁在致辞中表示高效便捷、低成本妥善化解劳动争议纠纷,既是劳动 者所盼,也有助于企业及时化解用工领域风险矛盾纠纷、护航保障企业可持续健康发 展,更是人力资源社会保障部门义不容辞的责任。

Labor dispute mediation center for foreign enterprises launched in Shanghai

With the support of the Shanghai Municipal Commerce Commission (SMCC) and the Shanghai Municipal Human Resources and Social Security Bureau (SMHRSSB), the Shanghai Labor and Personnel Dispute Arbitration Court and SHFIA jointly explored the establishment of a labor dispute mediation mechanism for foreign enterprises, and established the Shanghai Labor Dispute Mediation Center for Foreign Enterprises at the association. On the afternoon of April 11, a launch ceremony for the center was held at InterContinental Shanghai Jing'an, where Zhang Xiao, Second-Grade Counselor of SMHRSSB, and Liu Taiqiu, Second-Grade Counselor of SMCC, jointly unveiled the mediation center and presented letters of appointment to the first batch of part-time mediators. In his keynote speech, Zhang noted that the efficient, convenient and low-cost resolution of labor disputes goes in line with employees' expectations; helps enterprises resolve employment-related risks, conflicts and disputes in a timely manner, safeguards their sustainable and healthy development of enterprises; and comes as a bounden duty of human resources and social security authorities.

2024 年 4 月 11 日下午,上海市外商投资协会第九届会员代表大会第二次会议暨第九 届理事会第三次会议在上海静安洲际酒店召开。

第九届会员代表大会第二次会议由 2024 年度轮值副会长方毅杰主持。会议以无记名投 票形式选举产生 40 位理事;以举手表决的形式,通过了 5 项议案。会上,黄峰会长为 10 家企业颁发 2023 年度特别贡献会员奖,为 15 家企业颁发入会 30 周年以上会员证 书,并作第九届理事会 2023 年度工作报告和 2024 年度工作计划;监事代表张新作第 二届监事会 2023 年度工作报告。

The 2nd session of the 9th Member Assembly was chaired Fang Yijie, one of SHFIA's rotating vice chairpersons for 2024. The session elected 40 directors by secret ballot and passed 5 proposals by show of hands. At the meeting, Chairman Huang Feng presented the 2023 Special Member Contribution Award to 10 enterprises and honorary certificates for 30-year membership to 15 enterprises, and delivered the 2023 work report and 2024 work plan of the 9th Board of Directors. Zhang Xin, member of the Supervisory Board, delivered the 2023 work report of the 2nd Supervisory Board.

The 3rd meeting of the 9th Board of Directors was chaired by Xia Jun, also one of SHFIA's rotating vice chairpersons for 2024. 并联合召开新闻发布会,发布双语版本《商业秘密主要法律规范指引》《企业知识产 权法律保护指引手册》。上海市人民检察院第三分院党组书记、检察长贺卫,上海市 外商投资协会会长黄峰出席活动并讲话。根据《协作意见》,双方将开展五项服务: 加强常态化沟通交流与信息共享;构建外商投资企业知识产权快速维权通道;健全外 商投资企业知识产权合规机制;协力开展多元化知识产权法治宣传;打造知识产权全 链条法治服务平台。

Third Branch of Shanghai Municipal People's Procuratorate and SHFIA signed MoU over IPR protection mechanism for foreign enterprises

On the afternoon of April 24, the Third Branch of the Shanghai Municipal People's Procuratorate and SHFIA signed the *MoU on Building an IPR Protection Mechanism for Foreign Enterprises*, and co-hosted a press conference to release the bilingual versions of the *Guidelines on Main Legal Norms of Trade Secrets* and the *Guidelines for the Legal Protection of Enterprise Intellectual Property Rights*. He Wei, Party Secretary and Chief Prosecutor of the Third Branch of the Shanghai Municipal People's Procuratorate, and Huang Feng, Chairman of SHFIA, attended the event and delivered speeches. According to the MoU, the two sides will carry out five services:

- 1. strengthen regular communication and information sharing;
- 2. build a fast-track channel for the IPR protection for foreign enterprises;
- 3. improve the IPR compliance mechanism for foreign enterprises;
- 4. jointly carry out diversified legal publicity around IPR; and
- 5. create a full-chain legal service platform for IPR.



第135届广交会开幕,协会携近百家企业参展

2024年4月15日,第135届中国进出口商品交易会(简称广交会)开幕,展览规模 再创新高。本届广交会展览面积155万平方米,设55个展区,展位总数约7.4万个, 参展企业2.9万家,其中新企业超4300家。上海市外商投资协会作为上海交易团外资 分团组团单位,组织了99家企业参加本届广交会,共有线下展位347个,其中品牌 展位84个,占比24%。绿色特装和统一布展展位263个,占比76%。参展企业的展 品涉及工具、摩托车、建筑及装饰材料、餐厨用具、家居用品、箱包等30个展区。

SHFIA organized nearly 100 enterprises to participate in 135th Canton Fair

On April 15, the 135th China Import and Export Fair (Canton Fair) opened, with its scale reaching a new high. The exhibition area of this year's Canton Fair was 1.55 million square meters, with 55 exhibition areas, about 74,000 booths, and 29,000 exhibiting enterprises, including more than 4,300 first-timers. SHFIA, as the organizer of the Shanghai Trade Mission's Foreign Investment Sub-Mission, organized 99 enterprises to participate in the fair – they set up 84 brand booths, accounting for 24% of the total, as well as 263 specially decorated and uniformly decorated booths, accounting for 76% of the total. Their exhibits covered 30 exhibition areas including tools, motorcycles, construction and decorative materials, kitchen utensils, household items, luggage, etc.

Japanese Enterprises Branch: Analysis of Data Legislation and Supervision Trends, Interpretation of China's New "Company Law", and 2024 Cherry Blossom Viewing Party

On the afternoon of April 1, SHFIA's Japanese Enterprises Branch held the Analysis of Data Legislation and Supervision Trends, Interpretation of China's New "Company Law", and 2024 Cherry Blossom Viewing Party. At the event, Lawyer Zhang Xuchun, Senior Partner of Wintell Law Firm, offered professional analysis on the regulatory trend of data legislation in China; Lawyer Zhu Li, Director of Shanghai A&Z Law Firm, commented on issues that Japanese enterprises are strongly concerned about after the revision of China's *Company Law*, including improving the company's capital system, optimizing corporate governance, and strengthening the responsibilities of controlling shareholders, actual controllers, directors, supervisors, and senior executives; and Lawyer An Yiqing, Director of Shanghai Duan & Duan Law Firm, introduced the online pre-acceptance system for foreigner personal visas adopted by Shanghai's immigration authorities. After their presentations, enterprise representatives walked to Ruijin Hotel to appreciate the charm of cherry blossoms.
