## 本月聚焦 / Highlights

### 协会举办 2024 上海碳博会外商投资企业绿色低碳技术论坛

6月5日，在上海市商务委员会、上海市生态环境局共同指导下，上海市外商投资协会绿色低碳发展分会在上海浦东嘉里大酒店以“能源转型与零碳园区”为主题主办了“2024 上海国际碳中和技术、产品与成果博览会外商投资企业绿色低碳技术论坛”。上海市商务委副主任诸旖，上海市生态局科技与国际合作处处长施敏，上海市外商投资协会会长黄峰，上海市外商投资协会绿色低碳发展分会会长、巴斯夫大中华区董事长兼总裁楼剑锋博士等相关领导、专家、企业代表近 300 人出席本次会议。会上，以巴斯夫、金光纸业为首的多家会员单位共同成立了“零碳循环纸杯先行者联盟”。协会与美国环保协会签署了战略合作协议。参会嘉宾们分别以氢能和零碳园区为重点作主题发言和圆桌讨论。

### SHFIA hosted 2024 Forum on Green and Low-Carbon Technology of Foreign-Invested Enterprises in Shanghai

On June 5, under the guidance of the Shanghai Municipal Commerce Commission (SMCC) and the Shanghai Municipal Administration of Ecology and Environment (SMAEE), SHFIA's Green and Low-Carbon Development Branch hosted the 2024 Forum on Green and Low-Carbon Technology of Foreign-Invested Enterprises in Shanghai with the theme "Energy Transition and Zero-Carbon Industrial Park" at Kerry Hotel Pudong. The forum was attended by nearly 300 officials, experts, and business representatives including Zhu Yi, Deputy Director of SMCC, Shi Min, Director of SMAEE's Science and International Cooperation Division, Huang Feng, Chairman of SHFIA, and Dr. Lou Jianfeng, Chairman of SHFIA's Green and Low-Carbon Development Branch and Chairman and President of BASF Greater China. At the event, the branch's several member enterprises led by BASF and Sinar Mas Paper jointly launched the "Pioneer Alliance for Zero-Carbon Circular Paper Cup". SHFIA also signed a strategic partnership agreement with Environmental Defense Fund of the US. And the forum attendants delivered keynote speeches and conducted roundtable discussions focusing on hydrogen energy and zero-carbon industrial parks.

On the afternoon of June 29, SHFIA hosted a networking event for Shanghai Magnolia Award laureates from foreign enterprises at the old city government building on the Bund. More than 30 guests including Fu Jihong, Vice Chairman of the Shanghai People's Association for Friendship with Foreign Countries, Luo Zhisong, Chief Economist of the Shanghai Municipal Commerce Commission, and 13 Shanghai Magnolia Award laureates attended the event. In his opening speech, Huang Feng, Chairman of SHFIA, said that to better connect with and serve Shanghai Magnolia Award laureates, the association plans to organize various forms of social activities every six months to strengthen the ties between laureates from foreign enterprises, enhance communication and interaction between themselves and with government authorities, and jointly contribute wisdom and strength to Shanghai's development.

2024年3月15日，国务院总理李强签署第778号国务院令，公布《中华人民共和国消费者权益保护法实施条例》（以下简称“《条例》”），自2024年7月1日起施行。为了帮助商业类会员企业更好地理解《条例》，2024年6月27日上午，上海市外商投资协会特邀上海市市场监管局消保处谢正豪处长为企业解读《条例》要点，会议由

上海市外商投资协会副秘书长马蓝主持，来自协会商业工作委员会的 40 多家会员企业代表参会。

#### **Commerce Committee: Interpretation of *Regulations on the Implementation of the Law on the Protection of Consumer Rights and Interests***

On March 15, Chinese Premier Li Qiang signed the State Council Decree No. 778, promulgating the *Regulations on the Implementation of the Law on the Protection of Consumer Rights and Interests*, which will come into effect on July 1, 2024. In order to help commerce-related member enterprises better understand the *Regulations*, SHFIA invited Xie Zhenghao, Director of the Consumer Protection Division at the Shanghai Municipal Administration for Market Regulation to interpret relevant highlights on June 27. The event was hosted by Wilson Ma, Deputy Secretary-General of SHFIA, and attended by representatives from more than 40 member enterprises from SHFIA's Commerce Committee.
