本月聚焦 / Highlights

协会召开第九届理事会第六次会议

12月10日，上海市外商投资协会第九届理事会第六次会议召开。会议由2025年度轮值副会长、昕诺飞（中国）投资有限公司政府事务负责人谢青主持。第二届监事会监事长、思科系统（中国）研发有限公司副总经理李韧密及部分监事列席。

会议以无记名投票形式，选举产生安费诺时代微波电子（上海）有限公司徐澜澜等9位副会长；以举手表决的形式，通过《关于部分理事辞去职务的议案》、《关于变更协会业务范围的议案》、《关于新设知识产权工作委员会的议案》。

人力资源分会秘书长殷颖、日资企业分会秘书长张颖、智能制造分会秘书长朱月、绿色低碳发展分会秘书长蒋永勇分别就各分会成立以来的工作情况作汇报。

黄峰会长通报“东西部协作云南青少年技能培训和就业项目”进展情况。

会后，协会特邀上海市宏观经济学会王思政会长就《国民经济和社会发展第十五个五年规划的建议》作专题解读。

SHFIA held 6th Meeting of 9th Council

On December 10, the Sixth Meeting of the Ninth Council of SHFIA. The meeting was moderated by Xie Qing, Rotating Vice Chair for 2025 and Head of Government Affairs at Signify (China) Investment Co., Ltd., where Li Renmi, Chairman of the 2nd Supervisory Board and Vice GM of Cisco Systems (China) R&D Co., Ltd., and some supervisory board members were also present.

The meeting elected nine vice chairs, including Xu Lanlan of Amphenol Times Microwave Electronics (Shanghai) Co., Ltd., by secret ballot; and passed resolutions by show of hands regarding the resignation of some council members, changes to SHFIA's business scope, and the establishment of a new Intellectual Property Committee.

Yin Ying, Secretary-General of the Human Resources Branch; Zhang Ying, Secretary-General of the Japanese Enterprises Branch; Zhu Yue, Secretary-General of the Smart Manufacturing Branch; and Jiang Yongyong, Secretary-General of the Green and Low-Carbon Development Branch, reported on the work of their respective branches since their establishment.

Chairman Huang Feng reported on the progress of the "East-West Cooperation: Yunnan Youth Skills Training and Employment Project".

After the meeting, SHFIA invited Wang Sizheng, Chairman of the Shanghai Macroeconomic Society, to give a special interpretation on China's 15th Five-Year Plan for economic and social development.

协会举办 2025 年上海市外商投资企业 ESG 报告及案例发布会

12 月 16 日，在上海市商务委员会、上海虹桥国际中央商务区管理委员会和上海市长宁区人民政府的指导下，上海市外商投资协会和上海市长宁区商务委员会共同主办了“2025 年上海外商投资企业 ESG 报告及案例发布会”。上海市商务委员会副主任何冬宾，上海虹桥国际中央商务区管理委员会副主任王新，长宁区人民政府副区长赵永尊，上海市外商投资协会会长黄峰，中国光大银行上海分行行长汤永东，协会跨国公司地区总部 ESG 分会会长、百威投资（中国）有限公司企业事务副总裁朱江柳及相关政府部门领导、专家及外资企业代表近 200 人出席，共同探讨外资企业可持续信息披露的本土实践与全球协同。协会跨国公司地区总部 ESG 分会副会长，斯凯孚（中国）有限公司 ESG 发展官及政府事务总经理王鑑明主持会议。

何冬宾副主任在致辞中表示，自 2024 年 3 月市商务委制订印发了《加快提升本市涉外企业环境、社会和治理（ESG）能力三年行动方案（2024-2026 年）》以来，上海持续推动 ESG 与可持续发展，上海涉外企业治理规范化与信息披露透明度也显著提升，未来，上海将不断完善政策体系与服务。王新副主任、赵永尊副区长分别致辞。

今年 8 月，协会面向在沪外资企业公开征集 2024-2025 年度发布的中国区 ESG 报告，以及全球总部发布的可持续相关报告中的在华 ESG 案例，经过前期征集、筛选和评估，2025 年度上海外商投资企业优秀 ESG 报告及案例在会上揭晓。黄峰会长和长宁区商务委许芳主任为获得“2025 年度上海外商投资企业优秀 ESG 报告”的十家企业授牌；协会副秘书长丁遂亮和分会长朱江柳为获得“2025 年度上海外商投资企业优秀 ESG 案例”的八家企业授牌。

为持续、深入、系统地赋能外资企业 ESG 能力建设，协会跨国公司地区总部 ESG 分会正式发起成立了“外资企业 ESG 报告专业委员会”，聘请了 12 位外资企业 ESG

相关负责人为专委会成员。黄峰会长和朱江柳会长在会上为专委会成员代表颁发了聘书。

黄峰会长以《2025 年度上海外商投资企业 ESG 报告解析》为题作主旨演讲。

安永(中国)企业咨询有限公司可持续发展合伙人张彬以《可持续信息披露的国际准则与国内指引的协同》为题作主旨演讲。

SHFIA held 2025 Shanghai Foreign-Invested Enterprises ESG Report and Case Release Conference

On December 16, under the guidance of the Shanghai Municipal Commerce Commission (SMCC), the Administration Committee of the Hongqiao International Central Business District, and the Changning District Government, SHFIA and the Changning District Commerce Commission co-hosted the 2025 Shanghai Foreign-Invested Enterprises ESG Report and Case Release Conference. The conference was attended by nearly 200 people attended, including He Dongbin, Deputy Director of SMCC; Wang Xin, Deputy Director of the Administration Committee of the Hongqiao International Central Business District; Zhao Yongzun, Vice Governor of Changning District; Huang Feng, Chairman of SHFIA; Tang Yongdong, President of the Shanghai Branch of China Everbright Bank; Zhu Jiangliu, Chairman of SHFIA's MNC Regional Headquarters ESG Branch and VP of Corporate Affairs at Budweiser Investment (China) Co., Ltd.; and leaders from relevant government departments, experts and representatives from foreign enterprises. The conference explored local practices and global collaboration in sustainability disclosure for foreign enterprises. It was moderated by Wang Jianming, Vice Chairman of SHFIA's MNC Regional Headquarters ESG Branch and ESG Development Officer and GM of Government Affairs at SKF (China) Co., Ltd.

In his address, He Dongbin noted that since SMCC formulated and issued the "Three-Year Action Plan (2024-2026) for Accelerating the Improvement of Environmental, Social and Governance (ESG) Capabilities of Foreign Enterprises in Shanghai" in March 2024, Shanghai has continuously promoted ESG and sustainable development. The standardization of governance and the transparency of information disclosure by foreign enterprises in Shanghai have also significantly improved. In the future, Shanghai will continue to improve its policy system and services. Wang Xin and Zhao Yongzun also delivered speeches.

In August 2025, SHFIA publicly solicited China business ESG reports published in 2024-2025 from foreign enterprises in Shanghai, as well as China business ESG case studies from sustainability-related reports published by their global headquarters. After preliminary collection, screening, and evaluation, the outstanding ESG reports and case studies of foreign enterprises in Shanghai for 2025 were announced at the conference. SHFIA Chairman Huang Feng and Director Xu Fang of the Changning District Commerce Commission presented awards

to ten companies that received the "2025 Shanghai Outstanding ESG Report" award; SHFIA Deputy Secretary-General Ding Suiliang and Branch Chairman Zhu Jiangliu presented awards to eight companies that received the "2025 Shanghai Outstanding ESG Case" award.

To continuously, deeply, and systematically empower foreign enterprises in building their ESG capabilities, SHFIA's MCN Regional Headquarters ESG Branch officially launched the "Specialized Committee for the ESG Reporting of Foreign Enterprises", appointing 12 ESG-related specialists from foreign enterprises as committee members. Huang Feng and Zhu Jiangliu presented appointment letters to representatives of the committee members.

Huang Feng delivered a keynote speech entitled "Analysis of the 2025 Shanghai Foreign Enterprise ESG Reports". And Zhang Bin, Sustainability Partner of Ernst & Young (China) Enterprise Consulting Co., Ltd., delivered a keynote speech entitled "Synergy Between International Standards and Domestic Guidelines for Sustainability Disclosure."

The roundtable discussion, moderated by Zhang Bin, featured Yi Lan, Sustainability Manager of Yihai Kerry Arawana Holdings Co., Ltd.; Huang Ying, Deputy GM of Sustainable Development and Quality Assurance of Metro Commerce Group Co., Ltd.; Sun Lingling, Deputy Director of Corporate Communications of Budweiser Investment (China) Co., Ltd.; and Si Fanfeng, Senior Director and Head of Asia Pacific Sustainability at Volvo Cars (Asia Pacific) Investment Holding Co., Ltd., who discussed the topic of "How to Tell the 'China Story' of Foreign Enterprises Through Sustainability Disclosure." 协会携手会员企业，开展第七次云南公益行暨新时代中学签约仪式

12月9日至15日，协会外企志愿服务工作委员会一行来到云南省怒江傈僳族自治州泸水市开展第七次公益行活动。来自麦可门、鹏卫齐、可乐丽、福特汽车、希尔顿、邦芒人力6家会员企业的11位志愿者，以及禄劝职业高级中学教师代表参加。

2025年，项目迎来重要里程碑——首批关注的老窝镇中学2022届学生初中毕业，值得关注的是，除6名学生升入昆明市禄劝职业高级中学接受全日制中等职业教育外，有27名学生升入泸水市新时代中学高中部。为了帮助更多学生了解并接纳多元成长路径，协会与泸水市新时代中学正式开展合作。12月11日，协会与新时代

中学合作备忘录签约仪式在校内举行。泸水市教育体育局副局长和少岱出席并致辞，在上海援滇干部联络组、怒江州人社局宋松副局长以及企业志愿者代表的共同见证下，新时代中学校长朱俊刚与协会高级顾问李洁共同签署合作备忘录。

12月10日至11日，外企志愿者们先后走进老窝镇中学和新时代中学，将职业见解、产业分享带进课堂。此外，志愿者们还参加了2025第二届职业梦想夏令营的学生交流座谈会。12月13日至15日，协会与邦芒人力的3位志愿者继续前往昆明，与云南省外商投资企业协会代表一同走进禄劝职业高级中学，通过公益课程、企业参访等活动，陪伴职教学子的成长之路。

SHFIA joined member enterprises in 7th Public-Service Visit to Yunnan Province, and held signing ceremony for New Era Middle School program.

From December 9 to 15, a delegation from SHFIA's Foreign Enterprise Volunteer Service Committee visited Lushui City, Nujiang Lisu Autonomous Prefecture, Yunnan Province, to conduct its seventh public-service visit. 11 volunteers from six member enterprises — Michelman, PVH, Kuraray, Ford, Hilton, and Bangmang HR — along with representatives of teachers from Luquan Vocational High School, participated in the visit.

In 2025, the project reached a significant milestone — the first batch of supported students from Laowo Town Middle School graduated from junior high school. Notably, in addition to six students entering Luquan Vocational High School in Kunming for full-time secondary vocational education, 27 students were enrolled to the senior high school section of New Era Middle School in Lushui City. To help more students understand and embrace diverse growth paths, SHFIA officially began its cooperation with New Era Middle School in Lushui City. On December 11, the signing ceremony for the Memorandum of Understanding between the SHFIA and New Era Middle School was held on campus. He Shaodai, Deputy Director of the Lishui Municipal Education and Sports Bureau, attended and delivered a speech. Witnessed by the Shanghai Aid-Yunnan Cadre Liaison Group, Song Song, Deputy Director of the Nujiang Prefecture Human Resources and Social Security Bureau, and representatives of enterprise volunteers, Zhu Jungang, Principal of New Era Middle School, and Li Jie, Senior Advisor of SHFIA, jointly signed the MoU.

From December 10 to 11, foreign enterprise volunteers visited Laowo Town Middle School and New Era Middle School, bringing career insights and industry sharings into the classroom. In addition, the volunteers also participated in discussions with students of the 2025 2nd Career Dream Summer Camp. From December 13 to 15, SHFIA and three volunteers from Bangmang HR continued their trip to Kunming, joining representatives of the Yunnan Provincial Association of Enterprises with Foreign Investment to visit Luquan Vocational High School, accompanying vocational students on their growth path through public-service courses and company visits.

协会召开第二届监事会第六次会议

12月10日，上海市外商投资协会第二届监事会第六次会议召开。李韧密监事长，方芸、毛玮莹、张广晓、支卫4位监事，黄峰会长，范红秘书长等协会管理团队出

席；协会 2025 年度轮值副会长谢青列席。会议由李韧密监事长主持。

监事会听取了关于变更协会业务范围议案的说明、协会办公室租赁续约情况的报告、协会 2025 年度关键业绩指标的执行情况报告，审议了协会 2025 年度审计机构、管理团队成员兼职情况等报告。

监事会对协会工作的规范化及取得的成效予以肯定，并表示将持续发挥监督职能，支持协会各项工作的开展。

SHFIA held 6th Meeting of 2nd Supervisory Board

On December 10, the 6th Meeting of SHFIA's 2nd Supervisory Board was held. The board's chair Li Renmi, along with four members — Fang Yun, Mao Weiyi, Zhang Guangxiao, and Zhi Wei — as well as Chairman Huang Feng, Secretary-General Fan Hong, and other members of SHFIA's management team, attended the meeting, where Xie Qing, SHFIA's rotating vice chairman for 2025, was also present. The meeting was moderated by Supervisor Board Chair Li Renmi.

The Supervisory Board heard explanations regarding the proposal to change SHFIA's business scope, a report on the renewal of SHFIA's office lease, and a report on the implementation of SHFIA's key performance indicators for 2025. The board also reviewed reports from the SHFIA's 2025 auditing firm and on the concurrent positions held by members of the management team.

The Supervisory Board affirmed the standardization of SHFIA's work and its achievements, and stated that it would continue to exercise its supervisory function and support the SHFIA's various tasks.

2025 年度上海市、区外商投资（企业）协会联席会议举行

12月12日，2025年度上海市、区外商投资（企业）协会联席会议在宝山区举行。会议由上海市外商投资协会、宝山区外商投资企业协会共同主办，浦东新区、黄浦区、徐汇区、静安区、普陀区、虹口区、杨浦区、闵行区、青浦区、奉贤区、金山区、崇明区外商投资（企业）协会参会，宝山区商务委员会主任许志康、副主任何超出席。会议由上海市外商投资协会秘书长范红主持。许志康主任致辞，介绍了宝山区投资环境最新发展情况。

本次联席会议聚焦 2026 年度合作活动计划、广交会组织工作、外资权益保护、ESG 四个主题。范红秘书长介绍了 2025 年度市、区外商投资（企业）协会跨区合作活动情况以及 2026 年度跨区合作活动计划征询情况；介绍了广交会外资分团组展情况。市外资协会副秘书长兼法务总监王烨君介绍 2025 年上海市外商投资企业权益保护工作。市外资协会副秘书长丁遂亮介绍了协会 ESG 工作情况。

各区外资协会结合自身优势及特点，分别对拟在明年推出的合作活动计划作介绍和

交流，并围绕外商投资企业权益保护和 ESG 工作展开讨论，在深化交流与合作、持续共谋发展上达成了共识。市外资协会会长黄峰在总结发言中表示，今年上海全市 16 个区均成立了外商投资协会，外商投资（企业）协会工作体系实现了全覆盖；今年的联席会议，市、区各外商投资（企业）协会间，确定了“合作共享”的主题及 2026 年的各项活动安排，期待 2026 年与各区协会持续优化和拓展多层次的合作共享机制。

2025 Joint Meeting of Shanghai City and District-Level Foreign Investment Associations was held

On December 12, the 2025 Joint Meeting of Shanghai City and District-Level Foreign Investment Associations was held in Baoshan District. The meeting was co-hosted by SHFIA and the Baoshan District Association of Enterprises with Foreign Investment. Representatives from foreign investment associations in Pudong New Area, Huangpu District, Xuhui District, Jing'an District, Putuo District, Hongkou District, Yangpu District, Minhang District, Qingpu District, Fengxian District, Jinshan District, and Chongming District attended the meeting, where Director Xu Zhikang and Deputy Director He Chao of the Baoshan District Commerce Commission were also present. The meeting was moderated by Fan Hong, Secretary-General of SHFIA, and Xu Zhikang delivered a speech, introducing the latest developments in Baoshan District's investment environment.

This joint meeting focused on four themes: the 2026 cooperation activity plan, the organization of the Canton Fair, the protection of foreign investors' rights, and ESG. Secretary-General Fan Hong introduced the cross-regional cooperation activities of Shanghai's city and district-level foreign investment associations in 2025 and the consultation on cross-regional cooperation plans for 2026. She also introduced the organization of foreign investment delegations at the Canton Fair. Wang Yequn, Deputy Secretary-General and Legal Director of SHFIA, introduced the work on protecting the rights and interests of foreign enterprises in Shanghai in 2025. Ding Suiliang, Deputy Secretary-General of SHFIA, introduced the association's ESG work.

Each district's foreign investment association, based on its own advantages and characteristics, introduced and exchanged plans for cooperation activities to be launched in 2026, and discussed the protection of the rights and interests of foreign enterprises and ESG work, reaching a consensus on deepening exchanges and cooperation and continuously seeking common development. In his concluding remarks, Huang Feng, Chairman of SHFIA, stated that all 16 districts in Shanghai have established foreign investment associations in 2025, achieving full coverage of the foreign investment association system. At this year's joint meeting, the city and district-level foreign investment associations determined the theme of "cooperation and sharing" and the arrangements for various activities in 2026. He expressed his hope that in 2026, they will continue to optimize and expand the multi-level cooperation and sharing mechanism with the district associations.

上海市外商投资企业知识产权保护圆桌会议

12月2日下午，“上海市外商投资企业知识产权保护圆桌会议”在协会召开。上海市知识产权局副局长余晨、上海市外商投资协会会长黄峰出席会议并讲话。上海市市场监督管理局、上海市人民检察院第三分院、上海市知识产权保护中心相关负责同志及金拱门、孩之宝、艾默生、科勒、博恬、国誉、德之馨7家外资企业代表参会。黄峰会长在开场致辞中表示，协会正筹备成立“知识产权工作委员会”，诚挚邀请企业共同参与，助力知识产权保护营商环境。

外资企业代表围绕商标注册、专利维权、跨区域刑事保护等多个方面的问题及建议，同与会政府部门、司法机关深入交流，相关负责人逐一回应解答。

余晨副局长在总结发言中，针对企业提出的知识产权保护诉求进行了系统性回应，并介绍了上海持续推进知识产权保护的各项举措。

Shanghai Roundtable Meeting on Intellectual Property Protection for Foreign Enterprises

In the afternoon of December 2, the "Shanghai Roundtable Meeting on Intellectual Property Protection for Foreign Enterprises" was held at SHFIA. Yu Chen, Deputy Director of the Shanghai Municipal Intellectual Property Administration, and Huang Feng, Chairman of SHFIA, attended and addressed the meeting. Representatives from the Shanghai Municipal Administration for Market Regulation, the Third Branch of the Shanghai Municipal People's Procuratorate, the Shanghai Intellectual Property Protection Center, and seven foreign enterprises — McDonald's, Hasbro, Emerson, Kohler, Hoppe, Kokuyo, and Symrise — participated in the meeting.

In his opening remarks, Chairman Huang Feng noted that SHFIA is preparing to establish an "Intellectual Property Committee" and sincerely invited enterprises to contribute to a favorable business environment for intellectual property protection.

Representatives of foreign enterprises engaged in in-depth exchanges with participating government departments and judicial organs on various issues and suggestions regarding trademark registration, patent rights protection, and cross-regional protection. Relevant officials answered each question raised by foreign enterprises.

In his concluding remarks, Yu systematically responded to the intellectual property protection demands raised by the enterprises and introduced various measures Shanghai has taken to continuously promote intellectual property protection.

“新《反不正当竞争法》及广告合规”培训

为帮助外商投资企业正确理解和适用新《反不正当竞争法》，及合法合规开展广告活动，上海市外商投资协会于12月4日下午举办相关政策讲座，邀请上海市市场监督管理局价监竞争处和上海市广告协会为企业提供专题培训与讲解，并现场解答企业问题。近70位外资企业市场营销、法务、政府事务等相关人员参会。

上海市市场监管局价格监督检查和反不正当竞争处副处长黄伟丰围绕新《反不正当竞争法》核心变化与适用要点，就数字经济竞争规则、滥用市场优势地位、新型混淆行为等重点领域进行解读。上海市广告协会副秘书长黄社德，结合典型案例围绕互联网广告监管重点领域、广告合规审查义务及法律责任等内容进行解读和剖析。建设银行上海分行全球金融服务中心副总经理顾蕊为企业解读了最新FT升级账户与跨境资金池政策。

Training on New Anti-Unfair Competition Law and Advertising Compliance

To help foreign enterprises correctly understand and apply the new *Anti-Unfair Competition Law* and conduct advertising activities legally and compliantly, SHFIA held a policy seminar in the afternoon of December 4. The seminar invited officials from the Shanghai Municipal Administration for Market Regulation (SMAMR) and the Shanghai Advertising Association (SAA) to provide specialized training and explanations to enterprises, and to answer their questions on-site. Nearly 70 people from foreign enterprises, including those specializing in marketing, legal affairs, and government affairs, attended the seminar.

Huang Weifeng, Deputy Director of SMAMR's Division of Price Supervision and Anti-Unfair Competition, focused on the key changes and highlights of the new *Anti-Unfair Competition Law*, interpreting issues such as digital economy competition rules, abuse of market dominance, and new types of confusing behavior. Huang Shede, Deputy Secretary-General of SAA, interpreted and analyzed key areas of internet advertising supervision, advertising compliance review obligations, and legal responsibilities, using typical cases. Gu Rui, Deputy GM of the Global Financial Services Center of China Construction Bank Shanghai Branch, explained the latest FT upgraded account and cross-border fund pool policies to enterprises.

范红秘书长在开场致辞中表示，国际知识产权保护是广大外商投资企业关心的话题，协会正在筹备成立“知识产权工作委员会”，旨在凝聚行业共识，发挥外商投资企业知识产权保护合力，共同提升知识产权发展水平。

WIPO 仲裁与调解上海中心负责人吕国强围绕“WIPO 国际知识产权争议的仲裁和调解”主题，全面介绍了 WIPO 仲裁与调解服务体系主要内容，并回答了大家的提问。康美包集团亚太北区法务及合规总监周颖以“跨国公司知识产权保护和纠纷解决策略”为题，剖析了跨境知识产权保护的复杂性，并阐述了 WIPO 仲裁与调解制度优势与典型适用场景。

3rd "Intellectual Property Salon": WIPO International Intellectual Property Dispute Arbitration and Mediation

In the afternoon of December 8, SHFIA held its third "Intellectual Property Salon", focusing focused on the theme "WIPO International Intellectual Property Dispute Arbitration and Mediation". Lv Guoqiang, Head of the WIPO Arbitration and Mediation Shanghai Service, was invited to give a presentation. SHFIA Secretary-General Fan Hong delivered the opening remarks, and Zhou Ying, Legal and Compliance Director of SIG Combibloc Asia Pacific North, shared practical insights. Representatives from the WIPO Arbitration and Mediation Shanghai Center and over 20 representatives from enterprises and professional institutions attended the event, which was moderated by SHFIA Deputy Secretary-General Wang Yejun.

In her opening remarks, Secretary-General Fan Hong note that international intellectual property protection is a topic of great concern to foreign enterprises. SHFIA is preparing to establish an "Intellectual Property Committee" to build industry consensus, leverage the collective strength of foreign enterprises in intellectual property protection, and jointly improve the level of intellectual property development.

Lv Guoqiang, Head of the WIPO Arbitration and Mediation Shanghai Service, comprehensively introduced the WIPO arbitration and mediation service system and answered questions from the attendants. And Zhou Ying, Legal and Compliance Director of SIG Combibloc Asia Pacific North, delivered a speech entitled "Intellectual Property Protection and Dispute Resolution Strategies for Multinational Corporations", analyzing the complexity of cross-border intellectual property protection and explaining the advantages and typical application scenarios of the WIPO arbitration and mediation service system.

上海市外商投资企业标准化协作平台专家聘任仪式暨标准化工作圆桌会议

黄峰会长在总结中表示，本次圆桌会议旨在构建“开放、透明、便利”的标准化协同生态系统。平台将协同主管部门，加大政策支持、发挥专家作用，重点推进标准信息精准推送、优化企业参与渠道、拓宽标委会准入等工作。

Expert Appointment Ceremony and Standardization Roundtable Meeting of Shanghai Standardization Collaboration Platform for Foreign Enterprises

To understand the current status and needs of foreign enterprises in participating in standard-setting work, further promote their equal participation in standardization work, and advance the institutional openness of standards, SHFIA, acting as the Secretariat of the Shanghai

Standardization Collaboration Platform for Foreign Enterprises, convened a roundtable meeting on standardization in the afternoon of December 22. Wang Yiyang, Deputy Director of the Shanghai Municipal Administration for Market Regulation (SMAMR), and Huang Feng, Chairman of SHFIA, attended the meeting and delivered speeches. Representatives from SMAMR's Standardization Division, Business Environment Division, Certification and Accreditation Division, and Product Supervision Division, the Foreign Investment Management Division of the Shanghai Municipal Commerce Commission, relevant standardization committees and professional institutions, experts appointed by the Shanghai Standardization Collaboration Platform for Foreign Enterprises, and representatives from 19 foreign enterprises participated in the meeting, which was chaired by Wang Yejun, Deputy Secretary-General and Legal Director of SHFIA.

In his speech, Wang Yiyang affirmed the achievements of the Shanghai Standardization Collaboration Platform for Foreign Enterprises over the past year and stated that SMAMR will provide more convenient conditions and stronger support for foreign enterprises to participate in standardization work. Li Jing, Director of SMAMR's Standardization Division, introduced Shanghai's relevant standardization policies and work plans. Wang Yejun delivered the annual work report of the Shanghai Standardization Collaboration Platform for Foreign Enterprises.

An appointment ceremony for experts of the platform was also held at the meeting, with Wang Yiyang and Huang Feng presenting appointment letters to the experts. The expert team will primarily be responsible for platform development and standard formulation and revision, providing enterprises with professional answers related to standards, disseminating standard policies, and providing solid professional support for the platform's subsequent standardization work. At the meeting, Gao Jingmei, Technical Standards and Compliance Project Manager of Rockwell Automation (China) Co., Ltd., spoke as an expert representative. Representatives from five foreign enterprises — IKEA, Siemens, Kokuyo, Kimberly-Clark, and Jerutali — engaged in in-depth exchanges with officials from participating government departments and standardization committees.

In his concluding remarks, Huang Feng said that the roundtable meeting aimed to build an "open, transparent, and convenient" standardization collaboration ecosystem. The platform will collaborate with relevant government departments to increase policy support, leverage the expertise of specialists, and focus on promoting the accurate dissemination of standards information, optimizing channels for enterprise participation, and broadening the access criteria for standardization committees.

2025年，12月24日，由上海市商务委员会主办、上海市外商投资协会承办的《上海市鼓励设立外资研发中心的规定》政策讲座举办，各区商务部门相关工作人员及

外商投资企业代表等 130 余人参会。

上海市商务委员会外国投资管理处郑天昊围绕《上海市鼓励设立外资研发中心的规定》进行解读，通过新旧政策条款对比分析，帮助企业准确理解认定条件、熟悉申报流程。协会副秘书长王烨君介绍了外资研发中心鼓励政策及便利措施，帮助企业准确把握税收减免、设备退税及通关便利等政策要点。企业代表在互动环节中提出了关于研发中心的认定标准、申报主体、后续优惠政策等相关问题，两位讲师逐一解答。

Seminar on "Regulations of Shanghai on Encouraging the Establishment of Foreign-Invested R&D Centers"

On November 25, 2025, the Shanghai Municipal Commerce Commission (SMCC) issued the *Regulations of Shanghai on Encouraging the Establishment of Foreign-Invested R&D Centers*, aiming to further support the high-quality development of foreign-invested R&D centers in Shanghai and promote their better integration into Shanghai's science and technology innovation system.

On December 24, 2025, a policy seminar on the regulation was sponsored by SMCC and organized by SHFIA. It was attended by more than 130 people, including officials from district-level commerce departments and representatives of foreign enterprises.

Zheng Tianhao from SMCC's Division of Foreign Investment administration interpreted the document, helping enterprises accurately understand the certification conditions and application procedures through by comparing old and new policy clauses. Wang Yejun, Deputy Secretary-General of SHFIA, introduced the incentive policies and facilitation measures for foreign-invested R&D centers, helping enterprises accurately grasp the key points of policies such as tax reduction and exemption, equipment tax refund, and customs clearance facilitation. During the Q&A session, corporate representatives raised questions about the certification standards, application entities, and subsequent preferential policies for R&D centers, which were answered by the two speakers.

On December 8, the "Sharing Session on Green and Low-Carbon Transformation Practices and Innovation Cases," jointly organized by SHFIA's Green and Low-Carbon Development Branch, the Shanghai Science and Technology Exchange Center (SSTEC), and the "Belt and Road" Low-Carbon Technology Innovation Cooperation Alliance, was held, gathering nearly 60 industry experts and representatives from foreign enterprises. Zhou Yuanyuan, Deputy Director of SSTEC and Secretary-General of the "Belt and Road" Low-Carbon Technology Innovation Cooperation Alliance, and Ding Suiliang, Deputy Secretary-General of SHFIA, were present. And Jiang Yongyong, Secretary-General of the Green and Low-Carbon Development Branch and Senior Director of Government Affairs at BASF Chinese, moderated the event and delivered a speech.

Zhou Yuanyuan shared her insights on the theme "Strengthening International Sci-Tech Exchanges and Promoting Green and Low-Carbon Technology Innovation and Demonstration Applications." The event was jointly organized by the Atherosclerosis Chemistry Group of the Cardiovascular Disease Branch of the Shanghai Medical Association, the Medical and Health Committee and the Automotive Branch of SHFIA, and Bosch (China) Investment Co., Ltd. Dr. Chen Zhenyue, Chief Physician of the Department of Cardiology at Ruijin Hospital affiliated with Shanghai Jiao Tong University School of Medicine, and Ma Lan, Deputy Secretary-General of SHFIA, attended the event, which was moderated by Yao Ting, Chief Producer of Medical Programs at the Shanghai Radio and Television Station.
